## Introduction

This document outlines the types of user licensing available with Alessa software. User licensing refers to a user role and determines the level of access that a user has to various application features. Access is based on the duties and functions that each type of user is expected to perform.

## View Licenses

License details, such as expiry and number of permitted users, are viewable on an Alessa server under **Start > Alessa > Instance Manager** and in Alessa on the **Configure** tab under **User Administration > Licensing**. The numbers depend on purchase, and licenses can be added.

A "No License" entry indicates that one or more user accounts were deleted.



## License Types

User types are System Administrator, Technical Administrator, Business Process Administrator, Expert User, Basic User, and Executive User.

### System Administrator

The default administrator for the application who is responsible for initial configuration and maintenance of Alessa. The System Administrator is granted access to all Alessa features.

Sample tasks include configuring the Alessa database, activating and deploying servers, and creating user accounts.

### Technical Administrator

After initial configuration by a System Administrator, a Technical Administrator can update the database, configure email and SMS settings, and configure analytics engines.

The Technical Administrator is denied access to business process data.

### Business Process Administrator

An individual responsible for overseeing or managing business processes. Sample tasks include configuring and managing business processes and associated objects, such as packages, tasks, and workflows.

At least one Business Process Administrator is required.

### Expert User

A power user who is involved in the process of managing and resolving exceptions that are generated. This user is able to view and perform actions on exceptions through dashboard panels, work item views, and reports. This user can be involved in configuring various objects that are required to enable the monitoring process. Sample tasks include configuring packages, parameters, and tasks.



## Basic User

A user responsible for reviewing or resolving exceptions generated for business processes through dashboard panels and work item views.

## Executive User

A user responsible for overseeing the overall performance of the Alessa implementation. For example, this user can be an executive sponsor who wants evidence that the overall objectives of the monitoring process are being achieved.
